**Time/Squadding:** 9:00 AM, 11:30 AM, 2:00 PM (Advanced squadding is recommended)

**Course of Fire:** NRA A-36 1982 targets at 50 feet

**Match 1:** 20 shots Prone/20 min. **Match 4:** 60 shot aggregate (agg.) of Matches 1-3

**Match 2:** 20 shots Standing/40 min. **Match 5:** 2 man ANYSIGHTs Team (combined agg. of Match 4)

**Match 3:** 20 shots Kneeling/30 min. **Match 6:** 2 man Junior—Metallic sight Team (combined agg. of Match 4)

5 min change over and 3 min prep period between positions will be provided

Juniors may shoot Anysights but will be eligible for Open awards only.

**Eligibility:** Open to all as defined by current NRA Rules section 2.0

**Rules:** Current NRA Smallbore Rifle Rules will govern the conduct of this tournament. ECI's will be required and made available if you need one.

**Classification:** NRA classification card or temporary book. Those without either will fire in the master unclassified class. Classes will be combined to the next higher class if there is less than 5 competitors.

**Fees:** NRA Registration Fee \$5.50, Match & Club fees \$14.50—Total Individual fee **\$20.00**  
**\$5.00 off for CT State and other State Association Members— \$15.00** : Show Member Card to Registrar  
Team registration \$4.00/ 2 man team

**Challenges:** \$1.00 fee per target for a competitor's own target; \$3.00 fee per target for another competitor's target. The fee is returned if the score changes. Shots already plugged are not able to be challenged.

**Awards:** At least 50% of the match fees will be returned to the shooters for the individual matches and at least 65% of the team fees will be returned in the form of awards. Awards will be determined in each class based upon the number of competitors in each class.

**Directions:** From 95-N & 95-S, take Exit 71 "Four Mile River Rd", Turn right onto Four Mile River Rd. At the end, turn right onto Boston Post Rd/ US-RT 1, Turn right (0.4 mile) at the 2nd right onto Plant's Dam Road and go about 0.6 mile. Range is on the right.
